2019 Annual Financial Statements

Dear Sir / Madam,

The board of "Fondazione di Previdenza EFG SA" ("Fondazione") and the board of "Fondo Complementare di Previdenza EFG SA" ("Fondo") ("Fondazioni") approved the 2019 annual financial statements during the meetings of April 27th, 2020.

2019 was an excellent year for financial markets, generating a net performance in the asset management of the Fondazione of 10.62% and of the Fondo of 11.10%.

As a direct consequence of the very positive financial results, the **Coverage Ratio** is at the end of 2019 in positive territory, despite the reduction of the Technical Interest Rate from 2.25% to 1.75% and the annual update of the technical bases (generational tables LPP2015G of the year 2020), reaching **105.6%** for Fondazione and **112%** for Fondo.

The annual accounts of Fondazione and Fondo closed the year with a gain, which led to a reconstitution of the fluctuation reserve for both foundations. This reserve has been of fundamental importance during the first months of a very difficult 2020, in which period financial markets have suffered important turbulences caused by the Covid-19 crisis.
